MEMBERSHIP:

Membership is open to any individual who has successfully completed an Royal College of Surgeons of Canada accredited post-graduate training program (or national equivalent) in Otolaryngology – Head & Neck Surgery, General Surgery, and/or Plastic Surgery and whose clinical practices focus on the surgical treatment of diseases and cancers of the head & neck and is a member in good standing with the Canadian Society of Otolaryngology – Head & Neck Surgery.

MISSION STATEMENT

To enhance and enable knowledge in Canada relevant to the surgical treatment of cancers and other neoplastic diseases of the head and neck, including both reconstruction and rehabilitation

SECONDARY GOALS:

- 1. To strive to promote and encourage the highest possible professional, academic and ethical standards pertaining to the surgical treatment of head & neck neoplastic diseases in Canada.
- 2. To encourage and enhance research and educational collaboration between institutions and individuals in Canada involved in Head and Neck Surgery
- 3. To promote and educate individuals and institutions in Canada regarding best evidence practice and quality guidelines pertaining to clinical treatment and training of practitioners involved in Head & Neck Surgery.
- 4. To remain dedicated to the common goals of the Canadian Society of Otolaryngology Head & Neck Surgery.

DELIVERABLES:

- 1. Bi-annual newsletter distributed to all members regarding important issues relating to Head & Neck Surgery internationally as well as within Canada including but not limited to policy and/or consensus statements, educational opportunities, research initiatives, as well as recognition of individuals or groups who have made important contributions to Head & Neck Surgery
- 2. Generation and dissemination of policy or consensus statements regarding aspects of head and neck surgery agreed upon my members of the Association of Canadian Head and Neck Surgery (ACHNS).
- 3. Delivery of educational materials and mentorship to any individual or institution desiring to enhance clinical and/or academic aspects of the surgical treatment of head and neck neoplastic diseases.
- 4. Facilitation and guidance regarding the initiation and maintenance of collaborative research programs
- 5. Formal assessment of advanced head & neck oncologic and reconstructive training / fellowship programs functioning at Canadian institutions.
- 6. Formal report delivered by the ACHNS Executive to the Canadian Society of Otolaryngology Head & Neck Surgery (CSOHNS) Council meeting during the CSOHNS Annual Meeting.
- 7. Annual meeting of ACHNS to coincide with the CSOHNS Annual Meeting to allow all associates of the ACHNS to present issues and initiatives pertinent to academic, professional and/or ethical aspects of head & neck surgery both nationally and within their respective province or territory.

SCOPE AND JURISTICTION

- 1. The Association of Canadian Head and Neck Surgeons (ACHNS) represents a collection of voluntary members who have a clinical, academic and/or research focus that lies in the surgical treatment of cancers and diseases of the head and neck. The ACHNS is not a licensing body and holds no jurisdiction over national, provincial and territorial licensing and/or accreditation bodies.
- 2. The intended scope of the ACHNS is to foster and develop life-long learning and excellence in Head and Neck Surgeons in Canada through facilitation of continuing medical education in members, generation and dissemination of national and provincial consensus statements, practice guidelines, and quality initiatives specific to the practice of head and neck surgery as well as voluntary assessment of fellowship training programs functioning within Canada.

GOVERNANCE

- 1. The Executive Council of the Association of Canadian Head and Neck Surgeons is comprised of one presidents, two vice presidents and a secretary. The president and vice-president positions are represented with members from each of the following geographic zones: Canada West (British Columbia, Alberta, Saskatchewan and Manitoba), Canada Centre (Ontario and Quebec) and Canada East (Maritime provinces and Newfoundland and Labrador). This represents a structure change from the previous 3 co-chair format of CAHNSO
- 2. The original Executive Council of the Association of Canadian Head and Neck Surgeons including the 3 Co-Chairs and Secretary were nominated during the meeting of the CSOHNS- Head & Neck Surgery Special Interest Group Annual Meeting during the 66th Annual Meeting of the Canadian Society of Otolaryngology Head & Neck Surgery on May 21, 2012 in Toronto ON.
- 3. All active members of the ACHNS who are members in good standing with the Canadian Society of Otolaryngology Head & Neck Surgery and who have completed an American Head and Neck Society accredited (or equivalent) fellowship AND/OR dedicate the majority (≥50.1%) of their clinical practice to head and neck oncologic surgery are eligible for executive council positions.
- 4. All active members of the ACHNS who are members in good standing with the Canadian Society of Otolaryngology Head & Neck Surgery and who have completed a American Head and Neck Society (or equivalent) recognized fellowship AND/OR dedicate the majority (≥50.1%) of their clinical practice to head and neck oncologic surgery are eligible for executive council positions are eligible for leadership positions on subcommittee and focus group under the jurisdiction of the ACHNS.

- 5. Potential executive council candidates are nominated by members prior to the annual meeting of the ACHNS and elected via open ballot during the annual meeting.
- 6. All executive positions will serve for a 3-year term renewable for a single term.
- 7. Members serving in Executive positions may be elected to other Executive positions once their term(s) have been completed.
- 8. Executive council members will be elected at the annual meeting of CAHNSO prior to starting their inaugural term in the year following that meeting.
- 9. Major policies arising from the ACHNS will be decided on via 2/3 majority vote. All policy decisions will be voted on via open ballot at the annual meeting of the ACHNS.
- 10. Minor policies and initiatives arising from the ACHNS will be disseminated by the executive to all active members of the association. Following a 30 day review period if no major issues or challenges to minor policy changes or initiatives have been formally sent to the executive, the executive council will decide via consensus within the council regarding this category of policy and initiatives.

SUB-COMMITTEES AND FOCUS GROUPS (Proposed)

- 1. Head and Neck Endocrine Surgery Focus Group
 - a. This focus group's mission is to improve ACHNS access to established, and available treatment guidelines and consensus statements, to enhance and encourage education on and to facilitate collaborative research regarding the treatment of thyroid and parathyroid diseases in Canada.
 - To interact and establish linkages with the existing Head and Neck Endocrine Committee functioning within the scope of the Canadian Society of Otolaryngology – Head & Neck Surgery
- 2. Canadian Head and Neck Oncologic and Reconstructive Surgery Education and Training Committee
 - a. This Committee's mission is to strive to advance and secure the quality of head and neck oncologic and reconstructive surgery education within Canada.
- 3. Research Committee
 - a. This committee's mission is to facilitate and encourage the development of collaborative research between individuals and institutions in Canada regarding topics specific to the surgical treatment of diseases and cancers of the head and neck.

RESOURCES AND BUDGET

Initially all resources and funds for the Canadian Association of Head and Neck Surgical Oncology were derived from voluntary contributions and donations of members and the Canadian Society of Otolaryngology – Head & Neck Surgery. Following ratification of the Association of Canadian Head and Neck Surgeons by members, annual dues will be instituted to generate operating funds and capital.

Starting in 2016 an annual fee for active members of \$150 CDN per annum was instituted.
